KNOW ALL MEN BY THESE PRESENTS:

That, we, all of legal age, and are residents of the Philippines, have on this day voluntarily associated ourselves together for the purpose of forming a non-profit / non-stock corporation (Association) under the laws of the Republic of Philippines, more particularly under Section 2-A of Executive Order No. 535 dated May 3, 1979.

AND WE HEREBY CERTIFY:

FIRST

That the name of said corporation (Association) shall be:

"FILINVEST EASTVILLE HOMEOWNERS ASSOCIATION, INC. (FEHAI)."

SECOND

That the purpose for which corporation (Association) is formed are as follows:

To promote the best interest, well being, as well as to safeguard the welfare of the residents and owners of property units within Eastville Subdivision, Cainta/Antipolo, Rizal.

In addition to the above, the corporation (Association) is also organized in preparation for the eventual turnover by the developer of all common facilities and the duties and responsibilities in the administration, subject to existing laws, to wit:

- 1. To adopt such measures as may be mecessary for the protection and safeguard of the members of the Association, as well as their properties, including but not limited to the power to contract for security, maintenance and other services within the subdivision.
- 2. To promulgate and adopt rules and regulations concerning the proper use, occupancy and enjoyment of all property units, as well as other facilities and services within the subdivision.
- 3. To provide for the maintenance, repair, sanitation and cleanliness of the common areas in the subdivision and for the beautification and improvement of the same, undertaking

the reconstruction, restoration and repair, if necessary, in whole or in part of any structure or contrivance due to damage destruction or obsolescence, etc.

- 4. To provide contracts for any other public utility services and facilities for the benefit of the members of the association and of the subdivision as well.
- 5. To provide and implement pertinent rules and regulations, if necessary / practicable approved the plan, schemes and specifications of the building, structures and other improvements that may be constructed or introduced within the subdivision in accordance with pertinent restrictions, rules and regulations.
- 6. To construct or erect ornamental and / or functional structures, to maintain parks and playgrounds and other facilities; to operate by itself or through a third party recreational facilities and services within the subdivision in order to serve the needs of the members of the Association and for others who are willing to avail such facilities and services.

Provided, however, that the Association shall be required to perform only such of the foregoing enumerated purposes as it shall, from time to time, deem to be in the best interest of the members of the Association, the residents of the subdivision, and property/ies therein including the facilities and other services that now exist or may hereafter be erected or built, and only to the extent that funds are available for such purpose.


